

The LPT 30 is primarily designed for installation in conjunction with a generator having a rated output of not larger than 4.5kw, an external power cord having a rated output of not larger than 120VAC, 30A, 1PH, 60HZ and an electronic inverter having a rated output of not larger than 3600 watts.

CONTACTORS: General purpose DPDT 30 amp relay COIL: 110VDC, 2 watts TIME DELAY: Custom time delay, 30 seconds nominal may bypass time delay with switch on board

** MAXIMUM SERVICE 120VAC, 30AMPS SINGLE PHASE: MUST BE USED WITH A CIRCUIT DISTRIBUTION PANEL HAVING A MAIN BREAKER RATED 30AMPS-1 POLE, OR LESS. SUITABLE FOR INSTALLATION IN CONJUNCTION WITH POWER SUPPLIES HAVING RATED OUTPUTS NOT LARGER THAN 120VAC, 30AMPS.

WARRANTY: The manufacturer warrants that this product shall be free from defects in material and workmanship for one year (twelve months) from date of purchase or eighteen months after date of manufacture, whichever is less. If, after our inspection, a defect is revealed, the unit will be repaired and returned, at our discretion. We will accept up to 1/2 hour (30 minutes) labor for the unit to be changed our or \$18.00, whichever is less. This warranty shall not apply to any product that shows evidence of neglect, misuse, or misinstallation, or that has been repaired or altered by any other party other than this company. Proof of purchase may be required.
